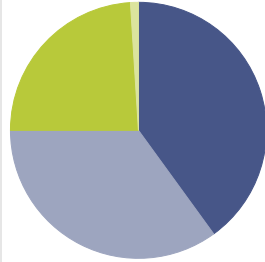

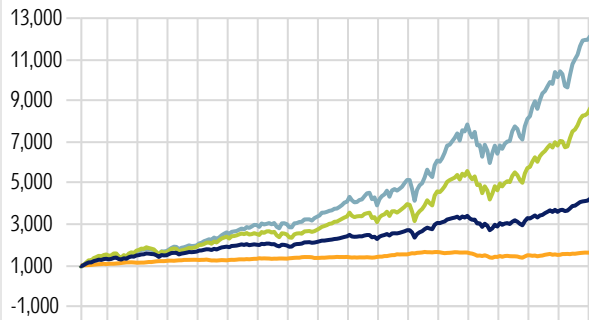

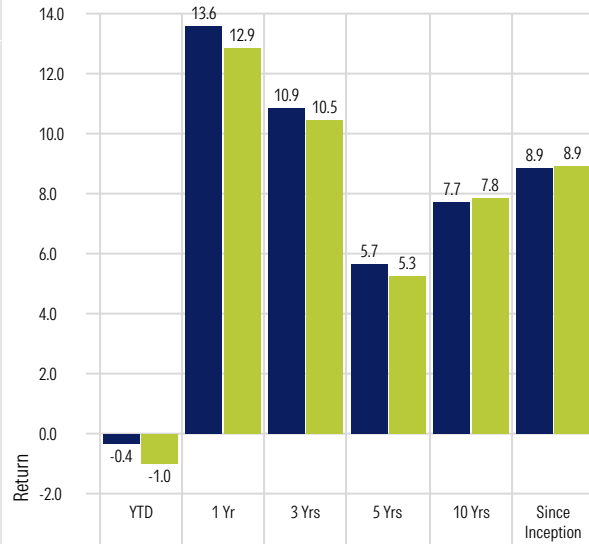
## Investment Growth of \$1,000

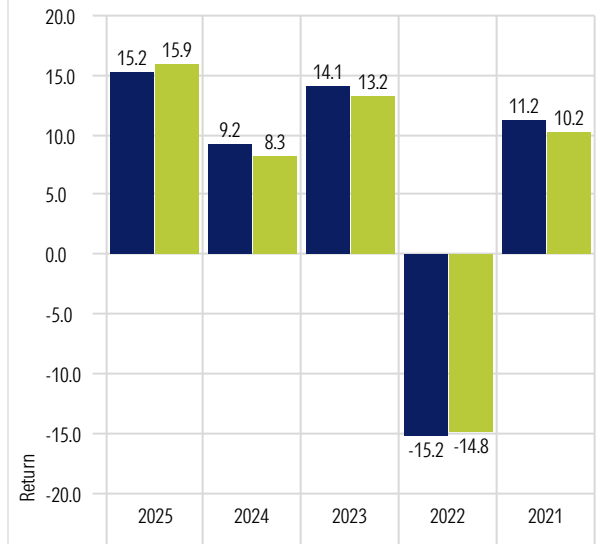
