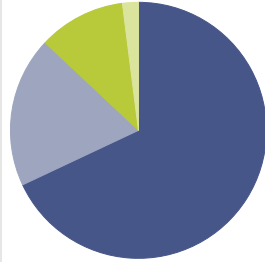

## Asset Allocation

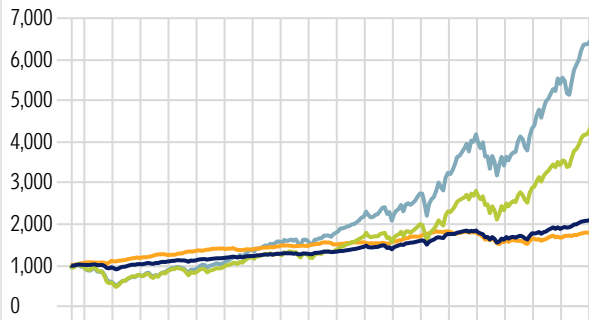

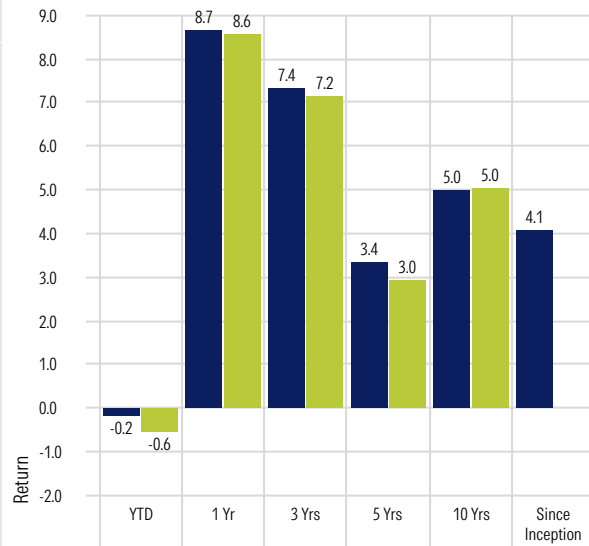

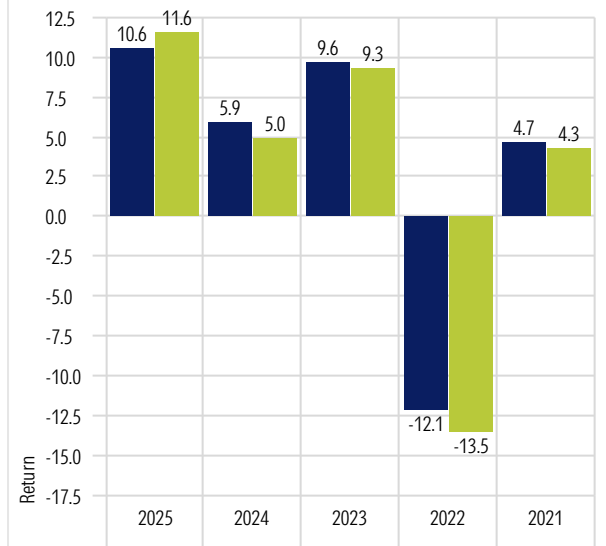
